The pre-qualification and bid documents duly filled in all respect should be submitted **online** to the Addl. Executive Officer, Murshidabad Zilla Parishad up to **13.00 Hours (as per server clock) on 09/11/2017 (Thursday)**. Murshidabad Zilla Parishad does not take any responsibility for the delay caused due to non-availability of Internet connection or traffic jam etc.

Necessary Earnest Money and Cost of Tender Paper will be deposited by the bidder electronically: online – through his net banking enabled bank account, maintained at any bank or: offline – through any bank by generating NEFT/ RTGS challan from the e-tendering portal [https://etender.wb.nic.]. Intending Bidder will get the Beneficiary details from e-tender portal with the help of Digital Signature Certificate and may transfer the EMD from their respective Bank as per the Beneficiary Name & Account No., Amount, Beneficiary Bank name (ICICI Bank) & IFSC Code and e-Proc Ref No. Intending bidder who wants to transfer EMD through NEFT/RTGS must read the instruction of the Challan generated from E-Procurement site. Bidders are also advised to submit EMD of their bid, at least 3 working days before the bid submission closing date as it requires time for processing of Payment of EMD. Bidders eligible for exemption of EMD as per Govt. rule may avail the same and necessary documents regarding the exemption of EMD must be uploaded in the EMD folder.

The pre-qualification documents alone will be opened on 15/11/2017 (Wednesday) at 2.00 p.m. by the Addl. Executive Officer, Murshidabad Zilla Parishad in presence of bidders present.

The date for opening of financial bid document of the technically qualified bidders will be notified after completion of technical evaluation and the other bid documents will be unopened. No individual intimation will be given. Name of the qualified bidders will be displayed **in the office notice board**.

Murshidabad Zilla Parishad reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

1) The applicant in the same name and style have should achieved annual turnover of the year over the average last three years following 100% of the proposed contract.

- 2) Trial Balance or Accounting sheet of the yearly turnover, debit, credit positions for the last 3 years [Audited by the CA Firm].
- 2) The applicant in the same name and style as prime contractor should have credential of at least **60%** of the proposed contract within the last three years in the same nature/style of single work & completed the work successfully.
- 3) Income Tax return should be uploaded for the AY-2015-16, AY-2016-17 & AY-2017-18 with the technical bid.
- 4) PAN Card, P. Tax Challan **for the financial year 2017-18**, GST registration Certificate & Trade License should be uploaded (Scan Copy).
- 5) To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources [Bank Solvency Certificate not less than **30%** of Tender amount within one year] sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
- 6) The prospective bidders should have **own** the required plant and machineries of prescribed specifications as shown in format. Conclusive proof of ownership must be submitted.
- 7) Registered Unemployed Engineers' Co-operative Societies/ Unemployed Labour Co.- Op. Societies are required to furnish valid Bye Law, Current Audit Report, Valid Clearance Certificate from A.R.C.S. for the last year along with other relevant supporting papers.
- 8) Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a Director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm, to upload such tender. **The power of attorney shall have to be registered in accordance with the provision of the Regulation Act, 1908.**
- 9) No Mobilization Advance / Secured Advance will be entertained.
- 10) Payment will be made according to the availability of fund.
- 11) The Bidders are encouraged to visit and examine the work site and its Surroundings to obtain necessary information that may be required before submission of Bid and entering into a contract for the work as mentioned in the Notice inviting Tender at his own cost and risk. For any quarries the bidders are requested to contact with the tender inviting authority during any working days. He can observe the plan & design of works to be executed before quote his rate from the office of the Tender Inviting Authority.
- 12) No Conditional/ Incomplete Tender will be accepted under any circumstances.
- 13) During scrutiny, if it is come to the notice of the tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice with forfeiture of earnest money forthwith and also penal action may be taken as per norms.
- 14) In case if there be any objection regarding non qualifying in technical bids the Agency that should be lodged to the Chairman of Tender Selection Committee within 48 (forty eight) hours from the date & time of publication of list of qualified agency and beyond that time schedule no objection will be entertained by the Tender Selection Committee.

15) Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the lowest tenderer if found necessary. After verification, if it is found that such documents submitted by the lowest tenderer is either manufacture or false in that case, work order will not be issued in favour of the Lowest tenderer under any circumstances and tender will be treated as cancelled, as well as the earnest money should be forfeited in favour of the Murshidabad Zilla Parishad.

16) The prospective bidders will have in their full time engagement experienced technical personnel, the minimum being one Civil Engineering Diploma holder. (Authenticated documents in respect of qualification and engagement for this work will have to be furnished for Technical Evaluation).

17) Bidder should have valid Registration with Employees Provident Fund Organization under EPF and Miscellaneous Provisions Act, 1952.

18) Receipt copy of deposit (Cost of Tender Paper & Earnest money) Challan should be uploaded with the tender documents

The amount of earnest money is 2% of the estimated cost of construction for each work. All duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills.**

The intending bidders are requested to inspect the work site alignment of the proposed work before quoting their rates.
