Block for a term of 1(One) year i.e from 31.03.2018. Applications have to be submitted to the office of the undersigned in plain white paper along with the under mentioned documents in support of their claim.

**Criteria:-**

1. Copy of Valid Trade License from the respective authority.
2. Valid I.T
3. Valid GST Registration Certificate.
4. Sketch map of storing point mentioning the capacity in metric ton (Go-down) along with copy of deed (in case of owned properties) or agreement of rent/lease (if not owned) should be submitted with the application.
5. Credential certificate in same nature of work if any.
6. Experience certificate if any in same nature work.
7. Candidate with prior experience may be considered in all respect.
8. Ability to transport food grain from the point of distribution to the delivery points.
9. After verification of Credential & Solvency of applicants, they will submit Affidavit (copy enclosed ) on a Non-Judicial Stamp paper worth of Rs. 10/- (Ten) along with a demand draft drawn in favour of the District Magistrate, Murshidabad MDM Account payable at Berhampore (WB) amounting to Rs. 5,000/- (Rupees- Five thousand) only as application fees (non – refundable).
10. Selected applications will have to furnished a security deposit of Rs. 1,00000/- (Rupes- One Lac) only in the form of bank draft in favour of the District Magistrate, Murshidabad (Mid Day Meal Account ) and payable at Berhampore.
11. The applicant / or Authorized representative will remain present at the time of opening as well scrutiny of the papers along with original copy of document(s) for verification.
