Scan copy of the earnest money (as mentioned against each work) and non-refundable amount as mentioned in column 4 & 5. Above towards the cost of tender paper/documents drawn in

favour of “Executive Engineer, WBSRDA, Murshidabad Division” payable at SBI-ADB, Berhampur Br, a/c no: -11176118727, IFSC Code: SBIN0003914 by RTGS/NEFT also be uploaded in the technical bid folder.

The pre-qualification documents (Technical Bid) alone will be opened on **14.01.2019 Time: - 11.00 Hours** and the date & time of opening financial bid document of the technically qualified bidders will be intimated in due time after technical evaluation technically qualified bidders will be declared. The other Financial Bid documents (Unqualified technical Bidders) will remain unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in Notice Board. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Executive Engineer, WBSRDA, Murshidabad Division reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

The eligibility criteria are given below: -

1. Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover at least 100% (similar nature of works) of the Estimated Amount put to tender. Tax Audit report in Last 3 years (F.Y-15-16, 16-17 & 17-18) (respective payment Certificate to be attached Govt. Department. Annual Turnover in contractual business should be authenticated by a Chartered Accountant.
2. The similar nature of credential (Issued from Only Govt. or Govt. Recognized Institute) should be submitted/uploaded at least 50% of the amount put to Tender supported by final payment Certificate and Completion Certificate within the last 3 years in the same nature/style of single work & completed the work successfully.
3. The Credential should be in the name & style of the intending tenderer only, and not in the name and / or style of any of the Partner(s). Please note that, Final Payment Certificate or Completion Certificate along with Work Order will only be entertained as CREDENTIAL. The bidder must have successfully completed PMGSY road or Post Five Years Maintenance Work of PMGSY road under WBSRDA with at least 50% credential by the Department in last Five Years for Programme Fund & Three Year for Maintenance Works or having at least 50% credential in similar nature of work in last three years from another Govt. Department and have to submit documentary evidence of the same i.e. Work Order, Completion certificate & Payment Certificate issuing the same shall not be below the rank of Executive Engineer or Executive Officer.
4. Income Tax return should be submitted/uploaded for the last 03 (Three) (F.Y-15-16, 16-17 & 17-18) financial years with the technical bid.
5. Professional Tax Receipt Clearance Certificate for the year 2017-2018, Pan Card, Trade Licence, Clearance Certificate up to date, to be submitted/uploaded.
6. Tax invoice(S) needs to be issued by the Supplier for raising claim under the contract, showing separately the tax charged in accordance with the provisions of GST Act' 2017.
7. Bidder should have valid Registration with Employees Provident Fund Organization under EPF and Miscellaneous Provisions Act, 1952. [Applicable only where the Tender amount is more than Rs.50.00 lakhs].
8. A prospective bidder shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm.
9. The partnership firm shall upload the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
10. Intending Labour Co-Operative Societies & Unemployed Engineers' Co-Operative Societies should enclose the documents in proof of their Registration & Validity to participate in this Tender during the period of deposition of the Tender. No exemption will be allowed regarding deposit of Earnest Money.
11. Receipt copy of Original deposit (Cost of Tender Paper & Earnest money) Challan should be submitted / uploaded with the tender documents.
12. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
13. All the documents in proof of their eligibility IN ORIGINAL should be uploaded all Original documents, any photo copy not received by the undersigned. If uploaded the photo copy tender documents not accepted by the undersigned.
14. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, his bid documents are liable to be cancelled.
15. To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources [Bank Solvency Certificate not less than 40% of Tender amount, Bank

solvency certificate not beyond 06 (Six) months, Applicable only where the Tender amount is more than Rs.50.00 lakhs] sufficient to meet the aggregate of the qualifying criteria for the individual contracts. The bidder should upload bank statement of the last Financial Year i. e. 2017-2018.

16. The scope of Sub-Contracting is not allowed strictly.
17. Filled up properly & Upload necessary documents in BIDDERFILE.
18. Prospective bidders shall have to execute the work in such a manner, so that appropriate service level of the road under improvement is to be maintained during progress of work till completion and a period of 2 (two) years from the date of successful completion of the work to the entire satisfaction of the Engineer-in- Charge. If any defect/ Damage are found during the period as mentioned above the contractor shall make the same good at his own expense to the specification at par with instant project work. 50% of Security deposit will be refunded after 1 (one) year and remaining 50% will be refunded after 2 (two) years as to be counted from the date of issuance of completion certificate by the E.I.C. The security may be extended up to 20% as per discretion of E.I.C.
19. The Bidder should submit affidavit on Rs. 10/- non-judicial stamp paper stating the information furnished with the tender document is correct in all respect.
20. Time allowed for completion of work as per mention in column No-06 from the date of issue of work order. The intending bidders are requested to inspect the work site before quoting their rates. The payment will be made as per availability of fund under post five years maintenance works.
21. Bidder/Agency must submit the prescribed earnest money from their own Account No, otherwise their bid will be treated as cancelled.
22. A Bidder who submit/upload More Than One Bids for the same NIT, the bidder's participation to be disqualified for both work.
23. Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:
 - I. Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).
 - II. Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays completion, litigation history, or financial failures etc.
 - III. Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.
 - IV. If anyone found to be submitting false or manufactured credential or other documents, then the bidder may be black listed and prevented from participation in any tender which will be issued from this Office for One (01) Year and the earnest money deposited for the said purpose is hereby forfeited.

All duties, taxes, royalties, cess [including 1% cess under W.B. Building and other Construction workers (Regulation of Employments & condition of service) Act, 1996], toll, taxes, and other levies payable by the Contractor under the Contract to the State/Central Govt. For any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% cess under W.B. Building and other Construction workers (Regulation of Employments & condition of service) Welfare Cess Act, 1996 will be deducted from the each running account bill.

Any objection regarding any Bidder or his tender documents the same should be submitted in this office before download or opening the financial bid. After opening the financial bid no such objection will be entertained.

WBSRDA MURSHIDABAD DIVISION reserves the right to accept or to reject any or all Tenders or can distribute a part or whole of any work to any or among more than one Tenderer without assigning any reason.
