The other Financial Bid documents (Unqualified technical Bidders) will remain unopened. No separate intimation will be given for this, unless the above date is changed. In case of change of date, due intimation will be given in Notice Board. No individual intimation will be given. Name of the qualified bidders will be displayed in the office notice board.

The Executive Engineer, WBSRDA, Murshidabad Division reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever.

**The eligibility criteria are given below: -**

1. Achieved in any one year during last Three years in the same name and style (excluding current year) a minimum financial turnover at least 100% (similar nature of works i.e Bitumen Works) of the Estimated Amount put to tender. Tax Audit report in Last 3 years (F.Y-15-16, 16-17 & 17-18) (respective payment Certificate to be attached Govt. Department. Annual Turnover in contractual business should be authenticated by a Chartered Accountant.
2. The similar type of credential (Issued From only Govt. or Govt. recognized Institute) should be submitted/uploaded at least 75% of the amount put to Tender supported by the Work Order, Final Payment Certificate or Completion Certificate within the last 3 years in the same nature/style of single work & completed the work successfully (similar nature of works i.e Bitumen Works).
3. The Credential should be in the name & style of the intending tenderer only, and not in the name and / or style of any of the Partner(s). Please note that, Final Payment Certificate or Completion Certificate along with Work Order will only be entertained as CREDENTIAL (similar nature of works i.e Bitumen Works).
4. Income Tax return should be submitted/uploaded for the last 03 (Three) (2015-16, 2016-17, 2017-18 A.Y) financial years with the technical bid.
5. Professional Tax receipt Challan for the year 2017-2018, Pan Card, Trade Licence, Clearance Certificate up to date, to be submitted /uploaded.
6. Tax invoice(S) needs to be issued by the Supplier for raising claim under the contract, showing separately the tax charged in accordance with the provisions of GST Act' 2017.
7. Bank solvency certificate 50% of the Estimated Amount should be issued any Nationalized Bank [Bank Solvency Certificate not beyond 6 months].
8. A prospective bidder shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm.

9. The partnership firm shall upload the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
10. **Each Bidder shall submit/upload Maximum two nos Bids in each serial of the NIT. A Bidder who submit/upload More Than Two Bids for the same NIT, the bidder's participation to be disqualified. Each agency is eligible to be get maximum two nos. of work against each set of own/lease machinery (Lease Agreement duly registered).**
11. **The scope of Sub-Contracting is not allowed strictly by any way.**
12. **Intending Labour Co-Operative Societies & Unemployed Engineers' Co-Operative Societies should enclose the documents in proof of their Registration & Validity to participate in this Tender during the period of deposition of the Tender. No exemption will be allowed regarding deposit of Earnest Money.**
13. Receipt copy of deposit (Cost of Tender Paper & Earnest money) Challan should be submitted/uploaded with the tender documents.
14. Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder.
15. All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required.
16. Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned the disputed amount, and the matter.
17. To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
18. **The scope of Sub-Contracting is not allowed strictly by any way.**
19. Prospective bidders shall have to execute the work in such a manner, so that appropriate service level of the road under improvement is to be maintained during progress of work till completion and a period of 1 (one) year from the date of successful completion of the work to the entire satisfaction of the Engineer-in-Charge. If any defect/ Damage is found during the period as mentioned above the contractor shall make the same good at his own expense to the specification at per with instant project work. **Security deposit will be refunded after 2 (Two) year as to be counted from the date of issuance of completion certificate by the E.I.C. The security may be extended up to 20% as per discretion of E.I.C.**
20. The Bidder should submit affidavit on Rs. 10/- non-judicial stamp paper stating the information furnished with the tender document is correct in all respect.
21. Negotiation with **L2** bidder is prohibited.
22. Time allowed for completion of work is 3/4 (three/four) months from the date of issue of work order. The intending bidders are requested to inspect the work site before quoting their rates. **The payment will be made as per availability of fund under post five years maintenance works.**
23. **Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:**
  - I. Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).
  - II. Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.
  - III. Participated in the previous bidding for the same work and had quoted unreasonably high or low prices and could not furnish rational justification for it to the Employer.

All duties, taxes, royalties, cess [including 1% cess under W.B. Building and other Construction workers(Regulation of Employments & condition of service)Act,1996],toll, taxes, and other levies payable by the Contractor under the Contract to the State/Central Govt. For any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% cess under W.B. Building and other Construction workers (Regulation of Employments & condition of service) Welfare Cess Act, 1996 will be deducted from the each running account bill.**

**Bidder(s) who is/are not able to upload current IT Return, current P. Tax Challan, GST Registration Certificate and EPF [applicable where the Tender amount is more than Rs. 50.00 lakhs] during tender submission, must submit the above documents with original to the under signed within 15 days from the date of opening of Financial Bid.
