

An open 'auction' will be organized on 16-01-2020 at 2:30 PM at the New Administrative Building (Office Chamber of Nezarat Deputy Collector, Berhampore) for sale of Old / broken / condemned / scarps and forsaken furniture and other items. Willing Persons / Farms / Agencies may join in this open 'auction' under the following terms and conditions:-


- 1) The initial bidding of this open 'auction' as per Annexure-I (Group A, B & C). Call base price fixed by the authority is binding to all.
- 2) A bank draft amounting to Rs. 5000/- (Rupees Five Thousand) only in favour of the District Magistrate, Murshidabad will be deposited at Nezarat Section, Murshidabad Collectorate within 11:30 a.m. on the date of open auction. Self attested photo copy of PAN / valid Trade License should be submitted with Bank draft.
- 3) The accepted bidding amount will be deposited on same day to the Nezarat Section, Berhampore, Murshidabad through DCR within office hours and produced for issuing lifting challan.
- 4) The articles of auction should be lifted by the accepted bidder within 03 (three) days in own cost in presence of authorized person. Gatepass will not be allowed without requisite office challan.
- 5) The deposited bank draft (security money) will be released within 15(fifteen) days from the date of 'auction'. The participant bidders will apply for releasing of the bank draft address to the District Magistrate, Murshidabad.
- 6) The date of 'auction' may be changed without any notice on administrative ground. If so, the next date will be informed with proper notice.
- 7) The bidder should take part in all group shown at annexure-I (A, B & C) and submit their rate on the consolidated initial base price shown in annexure – I. No rate will be accepted against group wise base (initial) price.
- 8) Each bidder must present at the time auction bid personally or through authorized persons.
- 9) Before taking part in the open auction one time visit will be allowed to all the interested bidders to show the condition of items on 14-01-2020 at 12:00 noon to 1:00 P.M.
- 10) The authority reserves the right to accept or reject any or all bids without assigning any reason what so ever.
