18	Imposition of any duty/tax/rule etc. owing to change /application in legislations/enactment shall be considered as a part of the contract and to be adhering to by the Bidder/Contractor strictly.
19	Bid Acceptance Authority is the Executive Officer, Berhampore Municipality.
20	In case of any dispute arising from any clauses of similar nature between bid documents and Municipal tender form, the decision of Executive Officer, Berhampore Municipality, will be final and binding.
21	All usual deductions for taxes i.e. ST, IT, and Labor welfare Cess etc. as applicable will be made from the bills from time to time (if applicable).
22	No conditional/ incomplete Bid shall be entertained.
23	Technical Bid & Financial Bid both will be submitted concurrently duly digitally signed in the website https://wbtenders.gov.in . Tender document may be downloaded from website & submission of Technical Bid/Financial Bid as per Tender Schedule.
24	The Bidder, at the Bidder's own responsibility and risk is encouraged to visit the store department of Berhampore Municipality to obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice inviting Tender, the cost of visiting the site shall be at the Bidder's own expense. Traffic management and execution shall be the responsibility of the Agency at his/her/their risk and cost.
25	The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the ULB. The Executive Officer, Berhampore Municipality reserves the right to reject any application for purchasing Bid documents and to accept or reject any or all the offered bid /bids without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidder at any stage of Bidding.
26	Prospective applicants are advised to note carefully the minimum qualification criteria as mentioned in 'Instructions to Bidders' before bidding.
27	During scrutiny, if it is come to the notice to Tender Inviting Authority that the credentials or any other papers found incorrect/manufactured/fabricated, that bidder will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.
28	Before issuance of the work order, the tender inviting authority may verify the credential & other documents with the original of the lowest bidder if necessary. After verification, if it is found that such documents submitted by the lowest bidder is either manufactured or false, in that case, L.O.A. / work order will not be issued in favor of the bidder under any circumstances.
29	If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later notification will supersede former one in following sequence: Municipal Form NIT Specia terms & Condition. Technical bid Financial bid
30	Contractor shall have to comply with the provisions of (a) the contract labor (Regulation Abolition) Act. 1970(b) Apprentice Act. 1961 and (c) minimum wages Act. 1948 of the notification thereof or any other laws relating thereto and the rules made and order issued there under from time to time.
31	Where an individual person holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual person shall, while uploading any tender for and on behalf of such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favor, by the rest of the directors of such company or the partners of such firm, to upload such tender. The power of attorney shall have to be registered in accordance with the provisions of the Registration Act, 1908.
32	Man power of the Operation: The rates shall be inclusive of operators provided. Accommodation and food for the Operators shall be arranged by the contractor at their own cost.
33	Tools, Plants and Consumables: Tools, Plants and Consumables required for installation, Operation and maintenance of equipment shall be provided by the contractor and the hire charges shall be inclusive of the same.
34	Safety: Installation, Operation and maintenance of the equipment shall be carried out as per standard norms and necessary safety precautions to be taken.
35	Payment will be made once in a month for the work complete, on certification of concerned authorities.
36	Contractor should pay the medical expenses to the contractor's workmen.
37	The safety of the men and machinery shall solely be the responsibility of the Agency.

38	The contractor shall arrange insurance coverage for the personnel employed on the work and the contractor should not engage child labour.
39	The workmen engaged by the contractor shall not have any right or claim for employment
40	Any applicable statutory taxes (like Income Tax, Work contract tax etc..) will be recovered from the bills as per rules (TDS).
41	The Contract is liable for termination in cases: 1) There is continued default by the Contractor for three days and if the concerned officer certifies that the performance of contract is not satisfactory. 2) The performance of Contractor is unsatisfactory at any stage
42	The persons employed by the contractor should be of his own employees and receives the wages from him. The Municipality would not accept any claim from the labour whatsoever. The contractor shall be responsible for payment of compensation as his employee(s) may be entitled to in the event of any accident or disability arising out of or during the course of his deployment with us and in all the events, the Municipality shall be indemnified from any claim.
43	Sub-contracting is not allowed. The contractor and his personnel adhere to the mines act and should work as per the directives of mines authorities.
44	Compensation of any sort under any situation like accidents, fires, extremists' activities etc shall be borne by the contractor and Municipality will not take any responsibility.
45	All protective measures of persons should be take care by the contractor. The contractor must provide suitable uniform to persons for identity and discipline.
46	The contractor must provide identity cards to his employees.

1. Payment Certificate will not be treated as Credential. Work order issued by the competent authority of a State/ Central Government, State /Central Government undertaking, Statutory/ Autonomous bodies constituted under the Central/State statute, on the executed value of completed work will be taken as credential.
2. Income Tax Acknowledgement Receipt for the latest Assessment year, P.T. Deposit Challan of last assessment year, for the year 2019-2020, Pan Card, G.S.T Registration Certificate, Valid Trade License accompanied with the Technical Bid Documents.
3. Registered Partnership Deed for Partnership Firm only along with Power of Attorney duly registered is to be submitted. The company shall furnish the Article of Association and Memorandum.
4. Registered Labor Co-operative Societies and unemployed Co-Operative societies are required to furnish valid Bye Law, last three years statutory Audit Report authenticated by A.R.C.S. along with Tax Audit Report in 3CD Form are to be furnished along with the Balance Sheet and Profit and Loss Account, Minutes of last A.G.M. , valid certificate from A.R.C.S. along with other relevant supporting papers.
5. Joint Ventures will not be allowed.
